
2. BUDGET AND FINANCES

<u>SSMU Budget:</u> After a hectic semester, I finally managed to complete the Financial Plan which has been sent to the General Manager and the Comptroller for feedback. Next meeting, I will bring forward the plan for approval for the February 9, 2012 Legislative Council meeting.

<u>Financial Transactions</u>: A separate report has been submitted; the report provides an overview of all financial transactions above \$1,000 within the SSMU.

<u>Clubs</u>: As usual, the office hours prove to be useful since many student groups drop by to readily ask questions or chat. In the next few weeks, I will be making a greater effort to promote the Club Audit in conjunction with the Clubs & Services representatives.

I also met with Councillor Winer to discuss the possibility of adding a sustainable component to the club audit. We decided that we will create an extra tab on the excel sheet where clubs will submit a sustainable report and according to the criteria, clubs that excel in sustainability will be provided a

<u>Services</u>: I will continue to set appointments with the different Services to touch base and review the finances to date.

Book Bazaar: Status quo.


