Full Status:

1) McGill Students for Israel- approved

McGill Students for Israel is submitting this application for full club status within SSMU. Since the beginning of the year, our membership has more than tripled, and we have formed a great community of dedicated students with shared goals. We hope to be able to increase our capacity to do in this semester going forward.

2) Sabela- Approved

As co-founders of SABELA, we feel privileged to have been met with such an enthusiastic response from the McGill community since we formed the club in March of last year. It is wonderful to see that there is a space for us within the array of clubs and societies at McGill, and that there is a shared interest in our cause even with so many other organizations focusing on issues in the developing world. In the past few months we have managed to sign up almost two hundred members, thirty to fourty of whom are

an active presence in our group, attending meetings and events.

With the hope of appealing to a diverse audience on campus we have hosted a variety of activities, looking to find a balance between fun and informative. Our first event was a bake sale, which had the goal of raising funds for our beneficiary

(SHAWCO), but was also our first time getting our name out in the community. We made and distributed business cards and flyers, encouraging students to take a look at our

Facebook page and our music streaming. We were thrilled to have raised upwards of \$450 from one day alone. The second event was an on campus movie night, where we screened the South African film "Tsotsi" which won the Academy Award for best foreign language film in 2005. While the film was gritty and violent, it gave an accurate portrayal of the issue of violent crime and the remaining economic disparity in South Africa. As part of the evening we also provided pizza, and charged a modest donation of \$2. Our last

event of the semester was a night at Factory Bar on St. Laurent, where we teamed up with

Hype Events and received a portion of the cover charge.

Interim status:

Mahjong Club- Rejected

Neglected Tropical Diseases- Approved
